There is clearly a growing need to have sound comparative information on occupational injuries and diseases, whether from a viewpoint of insurance, risk prevention or financial and incidence rate statistics.

Occupational risk insurance operates in an open environment, where the experience of various stakeholders enables them to improve their practices, or even design new systems. Current developments may have major consequences for the cohesion and principles of our existing protection model. By observing them, it may be possible to anticipate their impact.

This is the case, for example, of the future ISO 45001 standard currently being prepared, the recognition of work-related mental illnesses as occupational diseases or, more generally, the fundamental change represented by the digital transformation and its impacts on the working world.

All these essential issues and significant events described in this 2016 annual report illustrate the mission entrusted to us by the French OS&H insurance organization, which the EUROGIP Board of Directors and the whole team strive to accomplish.

#### **OUR 'RAISON D'ÊTRE'**

In Europe each year, there are close to 2.5 million occupational injuries, of which 3,500 are fatal, and occupational health problems are estimated to cost at least €145 billion.

The battle to improve this situation must first be won upstream. This requires developing deeper knowledge and exploring the best means of action, in France but also internationally. This is EUROGIP's 'raison d'être'.

At once an observatory and a resource centre, this public interest grouping set up by the French occupational risk insurance organization covers best practices for occupational injury and disease prevention and insurance at the international level and especially in Europe.

Accordingly, EUROGIP performs comparative studies involving several countries.


It publishes and disseminates European information useful for action concerning occupational risks, and encourages the exchange of experience through European conferences and bilateral meetings on new developments within its sphere of action.

It coordinates the experts of the French occupational risk insurance organization who take part in the production of European and international standards regarding occupational safety and health.

EUROGIP also coordinates a network of organizations whose role is to certify machinery and personal protective equipment so as to allow free movement of these products in the European market.

Finally, it takes part in projects of Community interest, notably on behalf of the European Commission.

EUROGIP thus enables French actors, in conjunction with their counterparts from the other countries, to improve occupational risk prevention and insurance based on best practices.

### **KEY EVENTS IN 2016**

#### Recognition of musculoskeletal disorders as occupational diseases in Europe



EUROGIP publishes results of a new study regarding the recognition of musculoskeletal disorders as occupational diseases in Germany, Austria, Belgium, Denmark, Spain, Finland, France, Italy, Sweden and Switzerland.

The report is organized around:

- an exhaustive overview of MSDs liable to be recognized as occupational diseases and the factors, which are taken into account for this recognition;
- 4 case studies which are representative of MSDs frequently affecting workers that illustrate national insurance regulations and practices regarding recognition and compensation;
- comparative incidence rate statistics which make it possible to assess the quantity of MSDs compensated by each of the countries and their evolution over the period 2007-2014.

#### Indicators of the accident rate at work: Comparison between France and Germany, 2010-2014

To generate finer trends and allow comparisons, EUROGIP publishes bilateral indicators in Germany and France from 2010 to 2014.

The information in this document intended to complement the harmonized statistics published by Eurostat. The challenge for EUROGIP is to identify, among the data available for the

two countries, those ensure both data comparability and monitoring over time. This document presents not only statistical data, but also financial ones, in particular active annuities paid to the insured following an

accident at work, a commuting accident or an occupational disease. It will be regularly updated to enable consistent monitoring of information over time. The information put into perspective by

EUROGIP comes from official data of the competent bodies of the two countries concerned, namely the Occupational Risks Department of the National Health Fund for

employees (CNAMTS) in France and die Deutsche Gesetzliche Unfallversicherung (DGUV) in Germany.

#### Taking part in external tasks, providing services

Based on its expertise and its activities, EUROGIP is asked to take part in certain tasks or provide services. For example, in 2016 it:

- did work jointly with the Dutch Institute for Asbestos Victims (IAS),
- supervised Eurostat's work on a new methodology concerning European occupational disease statistics,
- contributed to the writing of a report for the French National Directorate of Labour on mental illnesses in certain European countries,
- described to a Chinese delegation of the State Directorate General for Occupational Safety the role of the French OS&H insurance organization in OS&H standardization and "occupational injury" statistics in Europe
- outlined the main European systems regarding OS&H insurance and rehabilitation at the Comète France national congress,
- etc.



Openness to international practices regarding occupational injury and disease insurance and prevention is essential in order to keep an overall view of the solutions implemented in other countries. When Comète France organized a national conference in June 2016 on the theme 'Legislation and occupational health, what challenges?', it quite naturally contacted EUROGIP, to benefit from its expertise on these subjects. This made it possible to examine the actions carried out by Comète France from a European perspective and describe inspiring innovations that could be incorporated in the practices of our teams, which in 2016 assisted more than 9,500 patients in designing their socioprofessional integration plan.

#### **Networking**



#### European Forum of insurance against occupational injuries

The European Forum (http://www.europeanforum.org/) was founded in 1992 to promote and safeguard the principle of such a specific insurance against accidents at work and occupational diseases; moreover, it monitors actively the process of convergence between the systems in place in Europe.

In the framework of this European Forum, EUROGIP coordinates the "Occupational Diseases" working group and is deeply involved in the "Communication" working group and the Forum News publication, for which it is the French correspondent.

#### **Euroshnet**

EUROGIP is a member of the Steering Committee and the permanent secretariat of the Euroshnet network, which aims to facilitate exchanges between experts working in occupational risk prevention organizations on issues relating to standardization, certification, testing and associated research. It is mainly involved in the organization of European conferences, the website (www.euroshnet.org) and took part in the meetings between the directors of the KAN (Kommission Arbeitsschutz und Normung), INRS and EUROGIP.



Occupational safety and health (OSH) as well as social security are of great importance in all economies of the European countries. Therefore, the work done by EUROGIP is particularly relevant in a context and at a time when Europe tries more and more to find common solutions in these fields. EUROGIP is one of the main actors which facilitate the exchange of ideas and good pratice thanks to its publications and the "Débats" it organizes each year and to which the German Social Accident Insurance (DGUV) has already contributed several times. EUROGIP is one of these important links which make it possible for the European countries, although autonomous in the field of social security, to be informed of the developments in neighbouring countries and to find common positions on a growing number of initiatives and bills which derive from European politics.

#### **OH&S Standardization activity**

#### Coordination of experts

In 2016, 79 experts (CNAMTS-DRP\*, CARSAT, INRS\* and EUROGIP) took part in standardization work relating to OS&H. EUROGIP coordinates their work, provides them with various tools and training, organizes internal consultations on the draft standards submitted for enquiry to express an opinion on behalf of the Occupational Injuries Branch, finances registration fees to take part in commissions and co-finances the database of all OS&H published standards, etc.

#### Handling risk prevention problems

The OS&H insurance organization contributed to machinery market surveillance by means of a system that EUROGIP has organized through 'data sheets for handling risk prevention problems' produced by the personnel of the CARSAT\* funds when they detect incidents/accidents in the field.

#### Taking part in the strategic bodies

To exert influence on the normative consensus on behalf of the French OS&H insurance organization, EUROGIP takes part in the strategic bodies for OS&H standardization: AFNOR strategic policy committees on 'Health and Safety' and 'Management and Services', the 'Industry of the future' strategic impetus group, the European Strategic Advisory Body for Occupational Health and Safety standardization (CEN SABOHS) and the European 'Advisory Nucleus' committee for machinery.

### Taking part in the work of drafting the ISO 45001

Despite its opposition in principle to a standard in this area, the French OS&H insurance organization decided to take part in the work of drafting the ISO 45001 standard on 'Requirements for Occupational Health and Safety Management Systems and guidelines for use'. On its behalf, EUROGIP took part in international work [ISO PC283 WG1] and French work (AFNOR X82A standardization committee) to ensure that the draft is in accordance with the major French OS&H principles, but also with European directives and ILO guidelines.

#### Coordinating Notified Bodies for the regulatory certification of PPE and machinery



Under the authority of the French Ministries of Labour and Agriculture, EUROGIP acts as permanent secretariat for the French Coordinations of Notified Bodies for the regulatory certification of machinery and personal protective equipment.

The meetings that it organizes allow information to be exchanged between the ministries and the notified bodies, especially regarding the decisions taken during European meetings between Member States. They also aim to solve the often complex technical problems still remaining, to integrate standardization work and to prepare the positions to be defended at meetings of the vertical groups and/or the Horizontal Committee of the European Coordination. In 2016, the 'machinery' work mainly concerned the revision of the Guide to application of the directive and an impact study prior to the revision of the directive. The 'PPE' work concerned Regulation 2016/425 published in early 2016 and the accreditation of the French organizations following this new legislation. EUROGIP also took part in meetings of the European Coordinations and wrote or updated the directive interpretation sheets.
