A new EU Strategic Framework on Health and Safety at work (2014-2020)

Communication from the European Commission (6 June 2014)

On 6 June 2014, the European Commission presented a new Stategic Framework of action, cooperation and good practices exchances in the field of health and safety at work for the period 2014-2020. It is a Communication from the European Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committe of Regions.

Context

Waited for over a year by the Member States and in particular by the social partners, this framework has been developed from:

- the results of the evaluation of the European Strategy for health and safety at work covering the period 2007-2012,
- contributions from many stakeholders, including social partners, as part of a public consultation in 2013.

The new strategic framework is in line with the "Europe 2020" Strategy.

Results of the evaluation of the 2007-2012 OSH Strategy (31 May 2013)

According to the European Commission, the evaluation confirmed the importance of the European dimension of safety and health at work, particularly with regard to the positive downward trend in the number of accidents at work and the role of the EU strategy in the coordination of efforts and the establishment of a common framework for action. Among the actions still to be done, the Commission

cited in particular the following:

- improve the implementation of the provisions on safety and health in SMEs and micro-enterprises,
- develop more accurate tools for monitoring and data collection,
- greater emphasis on new risks and emerging occupational diseases,
- effectively address security issues and occupational health related to aging of the workforce.

3 key challenges require further policy action by 2020

SMEs, emerging risks and aging workforce - mentioned in the evaluation of the previous OSH Strategy - are the three challenges for the next 6 years:

- To improve implementation of existing health and safety rules, in particular by enhancing the capacity of micro and small enterprises to put in place effective and efficient risk prevention strategies
- To improve the prevention of work-related diseases by tackling new and emerging risks without neglecting existing risks
- To take account of the ageing of the EU's workforce.

Next steps

The Framework will be reviewed in 2016 in order to take stock of its implementation and to take into account the results of the on-going comprehensive evaluation of the EU occupational health and safety legislation which will be available by the end of 2015

- 217 millions workers in the EU
- 3 million workers victims of a serious accident at work every year
- 4000 workers die in workplace accidents every year
- the 2007-2012 EU Occupational Health and Safety Strategy helped to reduce the number of work accidents leading to absences of more than three days by 27.9% in the EU.
