FOREWORD

This document sets out a descriptive synthesis of the main available statistical data about accidents at work, commuting accidents and occupational diseases of the considered EU Member State.

It comes from the use by EUROGIP of various official publications from Member States. The data have been translated and presented according to the EUROGIP's knowledge of the analysed insurance system. These data have not been reprocessed by EUROGIP. For any confirmation, one has to refer to the source which is systematically given.

Comments do not intend to give explanatory factors to the figures but only to describe the underlying system's characteristics in order to allow the reader to analyse them.

Furthermore, Eurostat (Statistical Office of the European Communities) publishes, at European level, harmonised accidents at work data according to the ESAW (European Statistics on Accidents at Work) methodology in implementation of the 89/391/EEC framework directive. In order to complete national data, the last part of this document shows accidents at work structural indicators computed and published by Eurostat.

Accident Insurance alongside with the Pension Insurance and Health Insurance is the core of the Austrian Social Security system. This occupational risks insurance is governed by the September 9th 1955 *Allgemeine Sozialversicherungsgesetz, ASVG* [Social Insurances Main Act].

Roughly 5.8 million people according to the 2007 annual average are insured against occupational risks by four different insurance funds. AUVA insures 77% of them which includes workers, industry, trade and craft employees; professionals, rescuers, pupils and students. The insurance is managed by the *Allgemeine Unfallversicherungsanstalt, AUVA* [Social Security Institution for Trade and Industry]. AUVA is a public body.

Three other funds manage specific professional category insurance. The fund in charge of farming sector is the *Sozialversicherungsanstalt der Bauern, SVB* [Social Security for Farmers]; for the railroads and mining sectors the fund is the *Versicherungsanstalt für Eisenbahnen und Bergbau, VAEB* [Insurance Institution for the Austrian Railway and Mining Industries]. Last the public sector is covered by the *Versicherungsanstalt öffentlich Bediensteter, BVA* [Insurance Institution for Public Service Wage and Salary Earners].

These four insurance institutions are grouped under the umbrella association^[1] Hauptverband der österreichischen Sozialversicherungsträger, [Main Association of Austrian Social Security Institution] which attends to the Social Security general interests and represents them. The Association is itself under the control of the Federal Ministries in charge of Health and Social Affairs.

The following statistical data come from AUVA and cover workers; industry, trade and craft employees; professions and rescuers. Data regarding pupils and students, also insured by AUVA, are excluded.

Employers have to send AUVA their occupational injury notifications.

Accidents at work

Employers and/or doctors must legally notify fatal accidents and accidents that entail more than three days absence from work to the Labour Inspection and to AUVA within five days after the day of the accident.

Notification can be done through electronic means or by using the appropriate paper form. Medical certificates are also a source of information especially for accidents that entail less than three days absence. These data allow AUVA to codify accidents. All these information allow the recognition or not of an accident. The employee may dispute a negative decision which cannot be done by the employer.

AUVA may request an enquiry concerning non notified accidents. In case of a non notification, the employer faces a fine.

A central data base, managed by AUVA, regroups all of the accidents information. These data allow the victim's compensation to be calculated and are used for prevention purposes. Labour Inspection has access to these data. Statistics forwarded to Eurostat and to ILO (International Labour Organisation) come from this data base.

Occupational diseases

The Austrian system is a mixed one. To be recognized as an occupational disease (OD), the disease must have a cause to effect link with the professional activity and be listed within the 53 ODs' list of the Social Insurance Main Act's annex 1. The disease may also be recognized through the complementary system as a result of an enquiry conducted by AUVA. There is no period of exposure to risk specified but for damage to the meniscus (a three-year delay). Employers and/or doctors must legally notify OD to AUVA within five days after they have been informed. The worker may also file by himself a claim for recognition however in case of a recognition ex post facto compensation payment will be limited to two years. OD's recognition is the responsibility of AUVA insurance's doctors.

Financial contributions

Financial contributions are entirely the responsibility of the employers as they are supportive of each other. They all pay the same contribution rate. This 1.4% rate (dated on 1/1/2009 - calculated on a 4,020 \in monthly ceiling) is evenly applied to every company whatever their individual occupational risks records and size are. It covers the same way every occupational injury. Employers' contributions amount to 99.6% of AUVA financial resources. Self-employed workers pay either a monthly contribution lump sum or a contribution ranging from 1.4 to 1.9% of their wages.

Temporary disability compensation

The benefits are the same as the sickness cash benefits. The victim is entitled to his/her full salary during the first three days following the occupational injury. Then, the employer pays 100% of the victim's wages up to 6 to 12 weeks depending on how long the employee has been employed within the same company. Afterwards, for the 4 following weeks, 50% of wages are paid by the employer the other 50% are compensated by the Social Security. After these first 6 to 16 weeks, compensation is only paid by Social Security and comes to 50% of the wages and it is increased to 60% after a 6-week period. Compensation period is at least 52 weeks and up to 78 weeks. Additional compensation is possible for dependant family members.

Permanent disability compensation

Disability pensions are paid as soon as an occupational injury reduces the victim's capacity to earn a living by at least 20%. The pension depends on the disability rate. Amount's calculation is based on the past twelve months' wages. The pension is paid on a fourteen months basis. Victims having a disability rate of at least 50% till 70% are ranked as severely disabled persons and get an additional pension equal to 20% of the initial pension. Beyond 70%, the pension amount is increased by 50%. A 100% rate gives right to a full pension equalling to 2/3 of the wages calculation base. Disability rates of at least 50% give right to a 10% complement of the pension amount per dependant child. However, the amount paid must never in any case by superior to 100% of the pension calculation base.

The following occupational injuries data are concerning only the working population or 3,244,290 full and part time insured persons.

By law all occupational injuries with at least three days absence from work and the fatal accidents have to be notified to the insurer. However some accidents with at least one day off work are spontaneously notified.

In **2008**, among the 139,516 notified occupational injuries, 5,374 accidents have not been recognized (4,888 accidents at work and 489 commuting accidents) or 3.85% of all the notified accidents. So 134,142 accidents have been recognized.

Mandatory notified accidents account for 73,697 cases of which 66,860 are accidents at work and 6,837 commuting accidents. Information about accidents with less than 3 days off work comes from employers (for 1/3 of the cases even if the notification is not mandatory) and from health services which have a financial interest in reporting to the insurance.






Long term trends

Annual distribution of all recognized accidents









Expressed in incidence rates

Incidence rate = number of accidents x 1 000 / number of insured persons


Recognized accidents at work
