New standards publications, new works, registration of new subjects or comity creations... HEALTH AND SAFETY AT WORK STANDARDS PUBLISHED

NF EN 12929-1+A1 (revision) Safety requirements for cableway installations designed to carry persons - General requirements - Part 1: requirements for all installations

NF EN 13223+A1 Safety requirements for cableway installations designed to carry persons - Drive systems and other mechanical equipment
